## 2024 Pastor's Report: Kari Rinas

St Thomas Beloveds,

This has been another incredible year for our faith community. We have continued to grow in faith, participation, commitment, and numbers. We celebrated joys, mourned and carried one another's griefs and sorrows, welcomed new members, rejoiced at baptisms, fellowshipped, worshiped, and declared God's love in our wider community.

The ministry that we have achieved together this year has had a lasting impact in the Downriver area. We have touched lives in little and huge ways. We have made a difference to people, and our work has made a difference for our congregation and our future.

For all that we have done over this last year, I share my thanks and appreciation. First, for our Council members who have served our community; for our council members whose terms are ending: Paula Riley, Sandi Loso who has led as Vice President, and Art Wahl who has served faithfully as President. I am grateful for all their time and commitment to this congregation, for the work they did before my arrival, for their support and conversation as I got my feet under me, and for their continued work and love for St Thomas.

I give thanks for our staff who work tirelessly to strengthen our congregation, who go above and beyond their respective duties to see that our services, activities, and events all run smoothly, care for our property, and so much more that goes on behind the scenes.

I give thanks for each and every one of you—for your love and dedication in our congregation, for your prayers and support, for your giving of treasures, time, and self. I give thanks for all of the ways that you help to make St Thomas what we are, and the ministry that we provide.

When I first arrived at St Thomas, we knew that we were facing some challenges, particularly with our financial situation. There was strong lay leadership from our council and staff, and as we entered the 2024 year our leadership discerned that the next best steps to ensure the future of St Thomas and our ability to continue providing our community with the valuable ministry that we can do, was to pay off our mortgage.

The wisdom of our finance team and their continued guidance as we proceeded with our capital campaign, partnered with the generosity of our members and countless other donors, as well as your continued giving towards our general budget, meant that our campaign was more successful in the nine months than we could have imagined. We celebrated paying off our mortgage in full in October, burning the documents together and marking the day with treats and desserts.

As I reflected on that wonderful achievement and the last two years of our shared ministry, I realized that seems to be a theme for us together—we come up with a vision and this congregation sees the goal and surpasses it. Like our 60<sup>th</sup> anniversary celebration goals grew to an incredible festival of our ministry, we saw the need to pay off as much of our mortgage as we could, and you came together to not only meet *that* goal, but to get to where we are today, entering 2025: with greater financial freedom to now dream of what God is doing next and how we will respond and live into that future.

Even as we worked toward our mortgage campaign goal over the year, we also continued our other valuable ministries: Quilters met, our Christmas Market continued to grow, we provided for the needs in our community with the addition of our Blessing Box, we hosted a week for ChristNet and provided meals and volunteer help for another week at Grosse Ile Presbyterian Church, we joined in fellowship at Game Nights, Ladies' and Men's Lunches, we held Bible study, Confirmation classes, and so much more.

This year we also revived hosting a week of Vacation Bible School at St Thomas, and as usual, you all went above and beyond to make it a great week for the kids. We had about two dozen children participate over the course of the week, an outpouring volunteer help (some of my favorite moments were watching St Thomas adults interact with the kids!), and contributions were made toward the program to ensure that we had the supplies we needed for crafts, games, snacks, and decorations. The kids all had a great time during our week, felt God's love poured out for them, danced, sang, and learned some key Bible stories to remember that they can Trust God to always be with them.

For worship in 2024, we had a number of different experiences this year. I offered Ashes to Go on Ash Wednesday several times throughout the day for people who could not attend Ash Wednesday services. We had seventeen people pull up in our parking lot for a brief service with ashes, and any who wanted to, were also able to receive communion. Some of those who came were St Thomas folks, many were community members. Lent this year, we opted not to participate in the Downriver churches that rotate midweek services, and instead, planned our mid-week services to be on Thursday evenings with our usual Thursday worship time, and we had great participation for the services. Our Maundy Thursday service this year, we tried something new—we had a special service over a shared potluck dinner, that was well-attended, communion shared around each table as part of the meal, and then together, we moved into the sanctuary to conclude our service and work together to strip the altar. Easter celebrations were filled with joy and excitement as we rejoiced in the hopes and promises of the resurrection. There were weekly prayer walks during the summer months, the VBS kids led the Sunday worship service at the conclusion of the week of VBS, we remembered our beloveds who joined the Church Triumphant at All Saints. St Thomas hosted the community Thanksgiving service this year, which was a delightful evening to gather in worship and music in preparation for the Thanksgiving holiday. The Sunday School children provided a wonderful pageant just before Christmas. Our Christmas Eve service overflowed in joy, and we concluded the year with a service of Lessons and Carols with Picks and Bow providing the music for the day.

This year has been another declaration of God's love and all that can be done with God's guidance. The year ahead will not be without its challenges. We will continue to need your support; in prayers, commitment, financial contributions, gifting your time to volunteer, and simply being present with us. We are better when you bring yourself! We are better with *you* as part of our story in any way that you can be—when your story is wrapped together with our shared story as a congregation, that is wrapped up in God's bigger story for the world.

Together, we will continue to listen to God's call, as we seek to live into God's plans for us. We will meet challenges, inevitably we will grieve losses and disappointments together. We will learn and grow in faith, celebrate joys together, mark life transitions, carry one another, and care for others in our community and beyond. We will again host Vacation Bible School this summer, welcome guests from ChristNet, continue with our other ministries, and find new ideas and ways of serving.

As I so often say Beloveds, it is a joy to serve as your pastor, to help forge this path with you, and to see how God continues, and will continue to move in our midst. We may not be the largest congregation, but we are mighty, faithful, and salt our community with God's love in incredible ways. I am thankful for each one of you. Thank you for the privilege of being your pastor, as we discern what God is doing next through us!

## 2024 Council Reports

Members of St. Thomas Church,

It has been my privilege and honor to serve as Council President in 2024. We had a great year with solid weekly attendance, excitingly high attendance on Easter and Christmas, additionally being able to increase financial stability. The congregation took on the challenge of a major Capital Campaign, it was successful and allowed us to pay off our mortgage. To all of you that donated to this, "the future thanks you." Thank you also to everyone who kept up with regular giving, as this allowed us to operate smoothly through the year. (A detailed Financial presentation is included in the Annual Report.) Everything now working together with short and long term goals, allows St. Thomas to use our financial resources for mission, evangelism, community involvement and a host of other important work going forward. There will be three people elected to Church Council at this year's congregational meeting, with new officers being elected also for 2025. Please continue to support and pray for them as they work to guide St. Thomas. We thank Sandi Loso and Paula Riley for their dedication and work on church council these last few years, their influence and guidance has been instrumental in our success. They both will remain active in our congregation and church family.

Our congregation has grown over the last year, with both baptisms and welcoming new members. We are excited to have all of them become a part of the St. Thomas family, and I know you will welcome them and include them in events and projects our congregation is involved with. We have children in confirmation instruction, and we have had first communion instruction in 2024 for those that were ready for that. We were excited to have had a very successful Vacation Bible School this summer. If you know of someone that would like to be included in any of these groups, please let Pr. Kari know.

In 2024 we were able to continue to be a resource and helping hand in our community. Among those ways: We were able to not only continue to support ChristNet, we were able to host and provide a safe sleeping area in our building for a week. We now have a Blessing Box that is being used frequently in our parking lot by those that find help there. With our *Mom* to *Mom* sale and Christmas Market being so successful, it has allowed us to be even a larger helping hand in various other ways. As 2024 ended, we were able to substantially assist 10 local families with needed food and household products. Medical supplies, even a Blood Drive, and a variety of other donation drives are perpetually going on, please take a few moments to include these important things in your giving, and thank you to all of you that do! A goal of council this year was to increase volunteer help, we have done that for various teams but can always use more people and help, so if you can assist somewhere let us know and we will be thrilled to include you. Everyone is encouraged to think about and pray for ways they can contribute their skills, talents, and energy to St. Thomas, including our mission areas throughout the community and the larger world.

The future will present challenges for us all, not only on our own personal journeys but also in our desire to do God's work. #### Wendy Brozek, Church Council-Christian Education

#### Nursery:

- A furnished nursery continues to be made available for parents of young children to utilize during service.
- We now also have cable hook-ups to the nursery television to facilitate streaming the service while using the space.

#### Sunday School:

- Sunday School was held each week from January through mid- June and from September to December. One multi-age class was taught for children aged 3-10. Four teachers taught on a rotating basis. Average attendance was between 4 and 6 children per week. During the summer months, the children were seated at the front of the church with a table and chairs and given activities to keep them busy during the service.
- In 2024 we continued to use Cokesbury's Celebrate Wonder curriculum which allows teachers to select from a variety of activities each week that engage children of all ages.
- A television with an HDMI cord was installed in the room to aid in showing videos to accompany lessons.
- Our Christmas Program was held on December 22. Eight children, with help from Pastor Kari and adult members, put on a humorous play called, Just a Little Christmas. With sound effects and songs sung by the congregation, it was a collaborative success! Thanks to all who participated!
- Many thanks to our teachers who volunteered their time and talents to educate our young people –
   Wendy Brozek, Anna Gartner, Kathie Kline, and Marge Noyce.

#### Vacation Bible School:

- Camp Firelight VBS was held July 8-12, 2024.
- We had 29 students from ages 3 to 12 attend.
- We had about 30 volunteers help.
- Children had a great time singing, dancing, and interacting with Lu the Firefly puppet. They visited the Craft, Science, Snack, Games, and Drama stations.
- Special thanks to everyone who donated supplies. We had decorations, snacks and activity supplies all provided by generous donors which helped enhance our program immensely.
- Special thanks to all our volunteers for their dedication to such an awesome experience for the kids.

#### Confirmation Class:

• Pastor Kari organized an at-your-own-pace Confirmation Class, which held two in-person classes in 2024. Students are still completing their materials, but once all required work is completed, those two students will be eligible to be confirmed if they choose.

#### Adult Education:

- Tammy Howes led the Bible study class through June studying some of Paul's epistles.
- Pr Kari assumed leadership of the Bible study in October, focusing on passages for the upcoming Sunday services. Bible study was also moved from Mondays to Tuesdays.

Life at St. Thomas Lutheran Church for 2024:

2024 was a wonderful year in the life of St. Thomas Lutheran Church – we are healthy and renewed.

Some of the many activities that occurred within our congregation this year include the monthly Ladies' and Men's Luncheons, the Quilter's Group, and the Sunday Coffee Hour following service. We also continued to offer a nursery for younger children during Sunday services; a "welcoming" visitation to homes of new residents; Lenten services, including a drive through blessing and communion for Ash Wednesday; the Christmas Market with the addition of Mr. and Mrs. Claus plus 60 vendors; and our Giving Tree became Giving Wreaths this year, where we "adopted" two families, collected items for a Senior Living Center, and collected donations for the Michigan Humane Society of Monroe.

This year we also began or reinstated the following activities: Adult Weekly Bible Study, a confirmation class, a game night, a card making event, children's Vacation Bible School, and a Blessing Box that offers food for those in need. We also hosted this year's Interfaith Thanksgiving Service for all five Grosse Ile churches.

Outside of our congregation, we participated in the following community events: *IslandFest*, the annual township festival; the island-wide garage sale; Interfaith Council (all five Grosse Ile Churches) to support Christ Net; a collection of non-perishables and paper products for Sacred Hearts Food Pantry.

The undertaking of a Capital Campaign to lower our mortgage was our great achievement this year. This was an entire Church membership and past members effort that, within 10 months, raised enough to pay off our ENTIRE mortgage-allowing a special service for burning our mortgage papers.

So Yes, we are a renewed, happy and growing Congregation.
